

**REGISTRATION OF CHILD CUSTODY DETERMINATION**

Documents Required for Filing

1. A letter or other document requesting registration.
2. Three (3) copies, including one certified copy of the determination to be registered.
3. Statement under penalty of perjury that the order has not been modified.
4. A parent attempting to register a foreign judgment must file a sworn statement of any child support arrearage due, including any unpaid health care expenses.

**FILING FEE**

Court cost for filing is \$427.00, plus any service fees, payable by cash, money order or cashier's check.

**NOTICE OF REGISTRATION OF FOREIGN CHILD CUSTODY ORDER**

You are hereby notified, pursuant to §30-3B-305, *Code of Alabama* (1975), that:

(a) A registered child custody determination is enforceable as of the date of the registration in the same manner as a child custody determination issued by a court of this State.

(b) A hearing to contest the validity of the registered child custody determination must be requested within 30 days after service of notice.

(c) Failure to contest the registration will result in confirmation of the child custody determination, and preclude further contest of that child custody determination with respect to any matter that could have been asserted.

(d) If a timely request for a hearing to contest the validity of the registration is not made, the registration is confirmed as a matter of law, and the person requesting registration and all persons served must be notified of the confirmation.

(e) Confirmation of a registered order, whether by operation of law or after notice and hearing, precludes further contest of the order with respect to any matter that could have been asserted at the time of registration.
